OLD BUSINESS:

1. In lieu of sending a gift basket to the AVA Convention, a donation of \$50 was sent from CRW. A thank you note has been received.
2. After the walk in Comfort, Carol O. attended a meeting to map out the walk event calendar for the Central Texas area thru 2020. CRW will have the following dates in 2019 of Sept 28th and Nov 9th. Added will be the Opt outside for the day after Thanksgiving. For 2020 the dates reserved are Feb 15th, April 25th, Sept 26th, and Nov. 14th. CRW will also host a Sunrise YRE during the summer.
3. Members are working on routes for the remaining two events this year. One is Balcones District Park to Walnut Creek Metropolitan Park and the second one at Mueller to showcase the new and non-profit development in that area. A discussion followed.

NEW BUSINESS

1. Discussion took place regarding incorporating parts of the Cultural Sights of Austin walk event (4/13/2019) into the Capital YRE. Carol O. outlined a possible route.
2. Carol O. will represent our club at the AVA Convention in Albany, NY. The expense to CRW will be the \$75 fee for Carol O. to act as the CRW delegate and to vote on the various proposed issues. A few other members will be at the convention for the walks, workshops, general meetings, and other adventures.
3. Discussion of the cost of our web-site, capably maintained by Stephanie K, took place. The cost to maintain the web-site will go up to \$15.99 a month effective 6/1/2019. Carol O. contacted some San Antonio clubs regarding the sites being used. Susan I. of the Texas Trail Roundup had a couple of suggestions for easy-to-use sites that are less expensive (\$3.95 per month). Carol O. will ask Stephanie K. to contact Susan I. for more information.
4. June is the end CRW's officers' volunteer terms. All current officers agreed to serve another term with exception Charles R. who serves as VP. Doug E. agreed to fill the VP position. It was moved, seconded, and unanimously approved to accept the slate presented. Thanks to Doug E. for stepping up and thanks to Charles R. for his service to CRW. Charles plans to remain an active member and walker.
